I am directed to refer to your letter No.MAHE/REG./UGC-Campus/01 dated June 11, 2001 and subsequent correspondence on the above subject and to say that the proposal of MAHE (Deemed to be University) for opening of its centre in India and abroad was considered by the Commission at its meeting held on 21<sup>st</sup> March, 2002 and the Commission resolved as under :-


The proposal of MAHE - Manipal Academy of Higher Education, Manipal (Deemed University) to accord permission for opening their multi-campus in India and foreign-campus abroad along with copies of the Agreement between MAHE and other agencies, in question, was considered. MAHE has requested to open its Centres/campuses in India in association with:

1. Surat Hospital Trust Association of Seventh Day Adventists, Surat, Gujarat
2. M.P. Birla Foundation Medical Society, Satna, M.P.
3. Manipal Hospital, Bangalore
4. Academy of International Education (AIE), Goa
5. Skyline Business School, Delhi
6. Institute of Ophthalmology, TELC Joseph Eye Hospital, Tiruchirapalli and abroad in association with :-
7. VMC Corporation Sdn. Bh.d. Malaysia
8. Al Ghurair Academy, Dubai
9. EVolution Info Tech Middle East., Al Rusayl Sultanate of Oman

In view to export Indian education abroad, the Hon'ble Members, while appreciating the MAHE move to go abroad to Malaysia, Dubai and Oman also found the agreement between MAHE and VMC Corporation Sdn. Bh.d. Malaysia; Al Ghurair Academy, Dubai; EVolution Info Tech Middle East., Al Rusayl Sultanate of Oman - in order. It was, therefore, DECIDED that MAHE be permitted to open its campuses abroad at Malaysia, Dubai and Oman.

The Hon'ble Commission, after having examined the Agreement with the other associations, schools, foundations, etc. for opening their multi-campus in India could not actually satisfy itself about the academic/administrative control of MAHE on these proposed multi-campus in India. It virtually sounded like a partnership programme and did not reflect its true spirit to open a virtual multi-campus in India. As such, the Hon'ble Commission DECIDED not to approve the proposals for Surat, Satna, Goa, Delhi and Tiruchirapalli.

The Commission also examined MAHE's proposal to open a Medical multi-campus in Bangalore at its own establishment at the Manipal Hospital, Bangalore. This was found in order.

It was RESOLVED

- That MAHE – Deemed University be permitted to open its foreign campuses at Malaysia, Dubai and Oman.
- That MAHE be permitted to open Medical multi-campus at its own Manipal Hospital at Bangalore.
- That MAHE be not permitted to open the multi-campus in India in association with Society, School, Institute and Foundation – at Surat, Satna, Goa, Delhi and Tiruchirapalli.



**ORDERS ON IA 2/10 AND 1/10**

These writ petitions were heard for final hearing for nearly 15 days immediately prior to summer vacation. It was reserved for judgment with an intention to pronounce the judgment on the reopening day. But, in the meanwhile according to the master, after summer vacation we are sitting at Dharwad and Gulbarga Circuit Benches. In the process, the judgment could not be completed. The admissions for the academic year 2010-2011 is in progress. Time schedule has been fixed. In those circumstances, these applications are filed for an interim order.



2. Learned counsel for the MCI opposed continuation of any interim order. He has filed his detailed objections to the applications.

3. Heard learned counsel for the parties on these interlocutory applications.

4. The dispute is regarding the number of students to be admitted to two medical colleges as against the sanctioned strength of 500. By the impugned orders, it has been reduced to 250. It is that reduction which is challenged and subject matter of one writ petition. The subject matter of another writ petition is regarding the percentage of NRI students to be admitted as against their claim of 25%, they are permitted to admit only 15%. In the last couple of years when the matter is pending, by interim order the colleges are permitted to admit students to the full strength i.e., 500 and the NRI quota has been fixed at



Now, that we have heard both the matters on merits and shortly, we will be pronouncing the judgment after return to the Principal Bench, in the facts of these cases, in order to see that the college, the students, the Government and the public at large are not put to any inconvenience, we feel it appropriate to continue the interim order passed on the earlier occasions even for the current academic year. Accordingly, for the current academic year 2010-2011, the colleges are permitted to admit students to the full extent i.e., 500 and NRI quota for this year is fixed at 15%.



For B.Pharm programme NBA accreditation is for 5 years from 27.07.2006. i.e. till 2010-11. As per the Gazette notification dated 22nd February 2010, the AICTE has repealed the AICTE (Constitution and Function of National Board of Accreditation) regulations, 2008 notified vide notification No.37-3/legal/2008 dated 26th May 2008. Consequently the erstwhile NBA, which was a constituent of AICTE has ceased to function. A new National Board of Accreditation has been established as a society Registered under the Societies Registration Act XXI of 1860. As per their notification dated May -20, 2010 all the institution who had earlier applied for accreditation, prior to the constitution of New National Board of Accreditation, are requested to furnish the information about the old applications could be processed expeditiously.

Hence Our accreditation is till 2010-11 academic year for B.Pharm programme, we will submit the application before December 2010. New website is also launched for the new National Board of Accreditation <http://www.nba-india.org/> for more details.

b) M.Pharm for 3 years from 27.07.2006 (Pharmaceutics) - Application for renewal of the accreditation is deferred due to a few technical reasons.

I am to say that the Expert Committee constituted by the University Grants Commission had reviewed the functioning of Manipal Academy of Higher Education, Manipal, Deemed to be University and has given some observations/ suggestions in its report. A copy of the report was sent to you vide this office letter of even number dated 17<sup>th</sup> February, 2010, to submit compliance report within three months in respect of the observations/suggestions /deficiencies pointed out by the Expert Committee. The compliance report is awaited. It is further observed that:-


- (i) Medical Multi-campus at its own Manipal Hospital at Bangalore and Off-shore campuses at Malaysia, Dubai and Sالتان of Oman has been started. Approval has not been taken from the M/HRD.
- (ii) Manipal college of Nursing, Bangalore is being run by the deemed to be university. Specific approval for Manipal College of Nursing, Bangalore has not been obtained by the deemed to be University.
- (iii) The MoA /Rules are not as per UGC guidelines.
- (iv) The Deemed to be University has not maintained corpus fund of Rs. 5 crores in the form of FDRs as required under the UGC guidelines.
- (v) Movable and immovable assets in the name of Kasturba Medical College and some other trusts are yet to be registered in the name of the deemed to be University.
- (vi) The final decision is yet to be informed regarding the issue of intake in respect of Kasturba Medical College, Manipal which is reportedly pending before the Hon'ble High Court of Karnataka.
- (vii) Deemed to be university has been running the following institutions without the approval of UGC/MHRD.
  - a. Manipal Institute of Management, Manipal
  - b. Manipal Institute of Jewellery Management, Manipal
  - c. Manipal Institute of Communication, Manipal
  - d. Manipal Centre for Information Science, Manipal
  - e. Manipal College of Allied Health Sciences, Manipal
  - f. KMC International Centre, Manipal
  - g. Manipal Institute of Regenerative Medicines, Bangalore
  - h. Manipal College of Nursing, Mangalore.
